• Further, a thorough public process should be completed before the city commits to purchasing cameras. The community needs to have the opportunity to understand the policy choices and provide the direction necessary for the city to acquire suitable equipment.

• The League agrees with authorizing misconduct investigations of police personnel with rankings below lieutenant who were involved in crowd control events.

• We support the requirement that the city develop a plan for a smooth transition between the Independent Police Review and the new community police oversight board. The addendum includes a Jan. 1, 2022 deadline to submit

proposed plans and we wonder when those plans will be made available to the public. It is critical that the city have a functioning civilian oversight system at all times during this transition.

• Finally, the importance of civilian leadership over the educational aspects of the Training Division became even more evident upon the recent release of the Rapid Response Team training presentation slides. We encourage you to give the new civilian head the authority to put an end to the use of training materials with objectionable content.
